One (1) item of material and labor to install all equipment outlined within this proposal at your Sturtevant, WI facility. Customer to provide a reasonably clear work area with access to lighting, electrical power and an uninterrupted work schedule. Final interfacing from incoming plant electrical power including designated disconnect switch to mainline runway conductors to be by others and is to be completed during the installation time for final testing. All pricing is based on weekday/weekend/holiday rates using non-union labor. Any relocation of any obstructions such as lighting, piping, etc. is to be completed prior to the start date of this installation.

Terms and Conditions:

- Payment Terms Net 30; subject to credit approval.
- Shipping and Handling are not included and will be added to the invoice.
- Freight is FOB Shipping Point.
- Price of repair includes parts and or components as noted for the proposed scope of work.
- Additional repair requirements potentially found during the completion of the quoted repair are not included; the cost and lead time of these added repair requirements shall be quoted upon request.
- CRANE 1 will comply with all applicable state and federal safety requirements as well as those policies provided to us that are specific to the organization or site where the work is being performed.
- Unless otherwise noted, prices are quoted based upon free and clear access to the site and equipment.
- Delays or additional mobilizations caused by the customer or other contractors shall result in cost adders based on our current standard rates.
- The customer shall dispose of all used oil and removed parts. Disposal fee and hazardous waste fee shall apply to materials requested to be removed from site.
- Standard rates are for work performed 7:00am to 4:00pm. Time and a half rate after 4:00pm and on Saturdays. Double time rates on Sundays.
- Proposals over \$10,000 are subject to the following payment schedule:
- 50% down payment.
- 50% upon completion.
- Payments by credit card are subject to a 3% processing fee.
